

**Acceptable Solid Waste** is garbage, refuse and waste materials generally produced by residential households, and commercial, industrial and agricultural operations. Otter Tail County or its assignee may identify certain types of waste as unacceptable and refuse to accept it. Acceptable waste may include such other wastes as specialty wastes that may be approved from time to time by the Minnesota Pollution Control Agency and the parties to this contract.

**Unacceptable Solid Waste** means the following:

- a) Animal, fish or fowl remains in large quantities.
- b) Ashes, construction debris or demolition materials which include items such as oversized wood pieces, asphalt singles, sheet rock.
- c) Explosive waste.
- d) Glass - any amount of glass from automobile replacement glass, window replacement, and construction projects containing anything larger than insignificant household quantities.
- e) Hazardous waste as defined by federal and state laws or regulations.
- f) Hospital waste which is infectious, hazardous, flammable or toxic.
- g) Human remains.
- h) Infectious wastes.
- i) In general large quantities of any materials that would be considered non-combustible.
- j) Large machinery parts, such as gasoline tanks, hardened steel shafts, engine blocks and steel wheels.
- k) Large metal items.
- l) Liquid waste of any type in large quantities.
- m) Paints, solvents, gasoline and flammable liquids.
- n) Pesticides, insecticides, chemicals or other toxic materials (when not normally in residential or commercial waste).
- o) Propane tanks.
- p) PVC plastics (in large quantities).
- q) Radioactive waste.
- r) Raw animal manure and septic tank pumping's.
- s) Rocks.
- t) Steel banding.
- u) Steel fence materials.
- v) Tires.
- w) Used oil and oil filters.
- x) Waste items containing mercury, lead, cadmium, zinc, or other heavy metals.
- y) Any of the following: sewage sludge, lime sludge, grit chamber cleanings, bar screenings and other sludge, unless approved by the Director of the Minnesota Pollution Control Agency.
- z) Any other substance deemed unacceptable by the Minnesota Pollution Control Agency.
- aa) Appliances of any kind.
- bb) Electronics ( CPU, TV's, any item with a screen)
- cc) Large quantities of Rubber ( any kind)

- dd) Ink Toner or cartridges ( fire hazard)
- ee) Bulky furniture items
- ff) Bed Mattresses
- gg) Water heaters and softener systems.

When a material has not been identified on this list specifically all you need to do is ask the question, do I think this should go to the Perham Resource Recovery Facility?

The answer would be NO!!
